### Addendum to Services

"Consultant" will provide consulting and project management services related to Client's needs in the department of Communications, including but not limited to: 1) identifying, analyzing, and addressing Client's needs associated with branding and operationalizing communication at the district level, 2) coaching departmental leaders while concurrently partnering with them to build out and execute communication plans that are aligned with a district-wide policy, as well as GHTX' goals and priorities, delivering strategic communication plan and 12-month schedule, 3) serving as advisor to campus level staff responsible for messaging and the delivery of communication to their stakeholders, 4) under the direction of and in close partnership with the Interim Superintendent, providing Public Relations, Public Information Act, and Crisis Communication support as needed; and 5) coach, advise, supervise, and work in close collaboration with GHTX' Marketing and Communication Manager (Liseth Vazquez) and Client's Legal Counsel.

To continue to build, maintain, sustain, and deliver best-in-class services to the Client, Consultant may increase capacity for Great Hearts America - Texas by subcontracting/hiring project managers and subject matter experts throughout the Term of this Agreement, and may do so as needed or as requested by Client.

## Summary of Client's Needs & the Service Provider's Additional Role & Responsibilities Corresponding to the Need

- Develop and update master communications calendar
- Execute on district-wide GHTX communication priorities and needs
- Be responsive to GHTX communication needs
- Coach and develop GHTX communication team members and other leaders to be stronger communicators
- Write and send key district communications
- Act as a member of the GHTX senior team leading communications
- Support administration with Public Information Requests (PIRs) and provide surge capacity as needed.
  - <u>Rationale</u>: Due to the overwhelming volume of public records requests (PIRs), often exceeding 100 hours a month of time and effort from district and campus staff, GHTX may require services of PACE to support/increase capacity when administrative personnel are over-extended and such requests exceed reasonable expectations of a non-profit educational institution to perform its legally required duties, execute its mission, educate students, support employees, and operate schools responsibly while also responding to PIRs within a reasonable timeframe.
    - GHTX and PACE agree to expand the scope of work to include PIRs when the volume and/or complexity of requests exceeds the capacity of district and campus personnel.
    - In accordance with <u>GOVERNMENT CODE TITLE 5. OPEN</u> <u>GOVERNMENT; ETHICS; CHAPTER 552. PUBLIC INFORMATION</u>, in partnership with the Superintendent and the GHTX' legal counsel, with periodic consultation from the Offices of the State Attorney General for Texas and/or State Comptroller, PACE's Communication support services may include organizing, gathering, compiling, and preparing content for PIRs in order for GHTX to respond within a reasonable and legally required timeframe.

- **3. Stakeholder Engagement:** Serving as advisor to campus level staff responsible for messaging and the delivery of communication to their stakeholders.
  - a. Together with the Great Hearts Texas superintendent and/or his designee(s), PACE LLC will engage with campus leadership and school-level communication managers to assess the needs in order to advise and support the highest areas of need unique to each campus.
- 4. Public Relations, Public Information Requests, and Crisis Communication: Under the direction of and in close partnership with the Superintendent, providing Public Relations (PR), PIR, and Crisis Communication support as needed.
  - a. Together with the Great Hearts Texas superintendent and/or his designee(s), PACE LLC, in collaboration with Client's legal counsel, will coordinate, prepare, and manage all communication related to PR, PIR, and crisis situations/urgent matters that arise.

## Great Hearts America - Texas and PACE LLC Proposed Addendum to Service Agreement: Communications

## **Consulting Agreement**

THIS CONSULTING AGREEMENT (this "Agreement") is made and entered into effective January 8, 2023 by and between Great Hearts Texas ("School" or "Client") and PACE, LLC ("Consultant" or "Service Provider").

#### RECITALS

WHEREAS, Consultant's owner, Dejah Behnke ("Behnke"), and individuals employed by Consultant, possess specialized knowledge of interest to Client; and

WHEREAS, Consultant desires to act as a consultant for Client and Client desires to engage Consultant on the terms set forth herein.

NOW, THEREFORE, consistent with the foregoing recitals, and in consideration of the mutual promises and covenants herein contained, the parties agree as follows:

**Engagement and Services of Consultant.** Subject to the terms and conditions of this Agreement, Consultant is hereby engaged by Client as a consultant to provide certain services as described above.

**Independent Contractor Status.** Consultant's and Behnke's status under this Agreement shall be that of independent contractors, and not that of employees of Client/School or otherwise. Neither Consultant nor Behnke shall have the right or authority, expressed or implied, to incur an obligation or liability on behalf of Client/School unless specifically authorized in writing. School is interested only in the results to be achieved, and the conduct and control of Consultant's work will lie solely with Consultant. During the term of this Agreement, Consultant agrees that Consultant shall devote as much of Consultant's productive time, energy, and abilities to the performance of the Services hereunder as is necessary to perform the Services in a timely and productive manner. Consultant shall not have an obligation to work any particular hours or any particular amount of hours. Consultant acknowledges that Client's fringe benefit plans are limited solely to Client's employees, and that neither Consultant or individuals under contract with PACE are eligible for, entitled to, and shall not participate in any of Schools'/Client's fringe benefit plans. Client will report amounts paid to Consultant by filing the necessary Forms 1099 with the Internal Revenue Service, as required by law. Client will not withhold or make payments for Social Security, make unemployment insurance or disability insurance contributions, or obtain workers' compensation insurance for Consultant. Except as otherwise provided herein, while performing the Services for Client, Consultant is expressly free to perform services for other parties and Client may contract with other businesses or individuals to perform the same services for Client/School as Consultant.

Great Hearts America - Texas and PACE LLC Proposed Addendum to Service Agreement: Communications

Term and Termination. The Term of this Addendum to the existing Agreement shall commence as of January 8, 2024 and continue until June 30, 2024 (the "Term"). On or before the expiration of the Term, the parties may agree to extend the Term for a specified period of time as set forth by mutual written agreement of the parties. This Agreement may be terminated: (a) at any time by mutual written agreement of the parties; or (b) by Client, for any reason, upon thirty (30) days' advance written notice. Notwithstanding the foregoing, Client may terminate this Agreement immediately and without advance notice if Consultant or Owner Behnke: (i) is convicted of any crime or offense; (ii) fails or refuses to comply with the reasonable directives of Client after advance written notice of at least thirty (30) days is provided to Consultant by Client and Consultant fails to cure such failure or refusal within the notice period; or (iii) is guilty of gross misconduct in connection with performance of the Services, as determined by Client/School in its sole discretion. For purposes of Section 3 (iii), gross misconduct shall mean severe misbehavior by Consultant or Behnke in performance of the Services that is related to physical violence, theft of Client assets or proprietary rights, extreme work negligence, or similar acts or omissions that damage Client/School or Client's/School's reputation.

**Compensation**. As compensation for the Services, School shall pay Consultant an increased retainer fee of \$15,000.00 per month and an additional fee of up to \$2,500.00 per month per Individual employed by PACE for the Special Projects and/or On-Call Services provided directly to Client as noted herein; thereafter, during the Term (the "Fee"), Consultant shall provide Client with a monthly invoice for Services provided in the prior month; such invoice shall detail the Services provided and the correlating Special Project(s) and Individuals assigned/under contract with/paid by Consultant. Client may incur additional Fees by Client for time and effort for tasks assigned or performed outside of the services outlined within this agreement; however, these additional time and effort fees shall not exceed \$2,500.00 per month and Client will not be responsible for additional fees that may exceed the above limit unless written notice is provided by Consultant and agreed to by Client prior to the completion of out-of-scope work.

Upon termination of this Agreement for any reason, Consultant shall only be due compensation for Services completed up to and including the effective date of termination.

**Expenses**. Consultant shall be responsible for business-related expenses necessary for Consultant to perform the Services. Client shall not reimburse

Great Hearts America - Texas and PACE LLC Proposed Addendum to Service Agreement: Communications Consultant for any business-related expenses unless agreed upon verbally or in writing prior to Consultant incurring such expenses, and in the event this occurs, Consultant agrees to provide a detailed expense report via the monthly invoice and shall include copies of receipts. As a 501(c)3 non-profit organization, Client is not responsible for state or federal taxes related to previously agreed upon reimbursements or expenses incurred by Consultant.

#### RECITALS

WHEREAS, Consultant's owner, Dejah Behnke ("Behnke"), has specialized knowledge of interest to School; and

WHEREAS, Consultant desires to act as a consultant for School and School desires to engage Consultant on the terms set forth herein.

NOW, THEREFORE, consistent with the foregoing recitals, and in consideration of the mutual promises and covenants herein contained, the parties agree as follows:

**Engagement and Services of Consultant.** Subject to the terms and conditions of this Agreement, Consultant is hereby engaged by School as a consultant to provide certain services as described on page one.

**Independent Contractor Status.** Consultant's and Behnke's status under this Agreement shall be that of independent contractors, and not that of employees of School or otherwise. Neither Consultant nor Behnke shall have the right or authority, expressed or implied, to incur an obligation or liability on behalf of School unless specifically authorized in writing. School is interested only in the results to be achieved, and the conduct and control of Consultant's work will lie solely with Consultant. During the term of this Agreement, Consultant agrees that Consultant shall devote as much of Consultant's productive time, energy and abilities to the performance of the Services hereunder as is necessary to perform the Services in a timely and productive manner. Consultant shall not have an obligation to work any particular hours or any particular amount of hours. Consultant acknowledges that School's fringe benefit plans are limited solely to School's employees, and that neither Consultant is not nor Behnke are eligible for, entitled to, and shall not participate in any of School's fringe benefit plans. School will report amounts paid to Consultant by filing the necessary Forms 1099 with the Internal Revenue Service, as required by law. School will not withhold or make payments for Social Security, make unemployment insurance or disability insurance contributions, or obtain workers' compensation insurance for Consultant or Behnke. Except as otherwise provided herein, while performing the Services for School, Consultant is expressly free to perform services for other parties and School may contract with other businesses or individuals to perform the same services for School as Consultant.

**Term and Termination.** The Term of this Agreement shall commence as of the date set forth above and shall continue until June 30, 2023 (the "Term").

#### **Great Hearts Texas and PACE LLC**

On or before the expiration of the Term, the parties may agree to extend the Term for a specified period of time as set forth by mutual written gareement of the parties. This Agreement may be terminated: (a) at any time by mutual written agreement of the parties; or (b) by School, for any reason, upon thirty (30) days' advance written notice. Notwithstanding the foregoing, School may terminate this Agreement immediately and without advance notice if Consultant or OwnerBehnke: (i) is convicted of any crime or offense; (ii) fails or refuses to comply with the reasonable directives of School after advance written notice of at least thirty (30) days is provided to Consultant by School and Consultant fails to cure such failure or refusal within the notice period; or (iii) is guilty of gross misconduct in connection with performance of the Services, as determined by School in its sole discretion. For purposes of Section 3 (iii), gross misconduct shall mean severe misbehavior by Consultant or Behnke in performance of the Services that is related to physical violence, theft of School assets or proprietary rights, extreme work negligence, or similar acts or omissions that damage School or School's reputation.

**Compensation**. As compensation for the Services, School shall pay Consultant a fee of \$6,000.00 for the month of January 2023, and \$10,000.00 per month thereafter during the Term (the "Fee"). Consultant shall provide School with a monthly invoice for Services provided in the prior month; such invoice shall detail the Services provided and time allocated to each task. Upon termination of this Agreement for any reason, Consultant shall only be due compensation for Services completed up to and including the effective date of termination.

**Expenses**. Consultant shall be responsible for business-related expenses necessary for Consultant to perform the Services. School shall not reimburse Consultant for any business-related expenses.

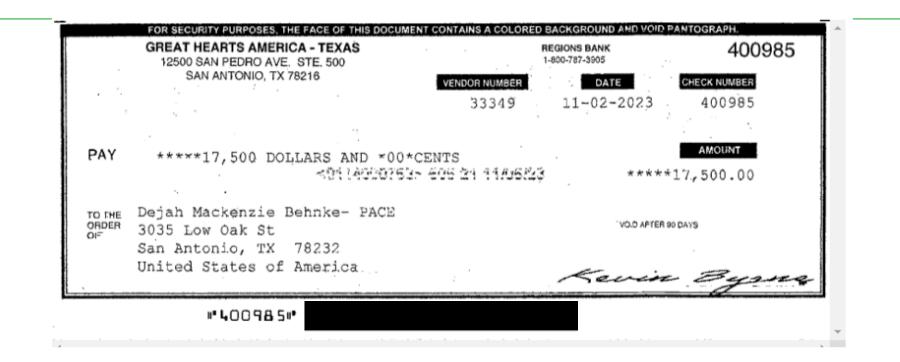

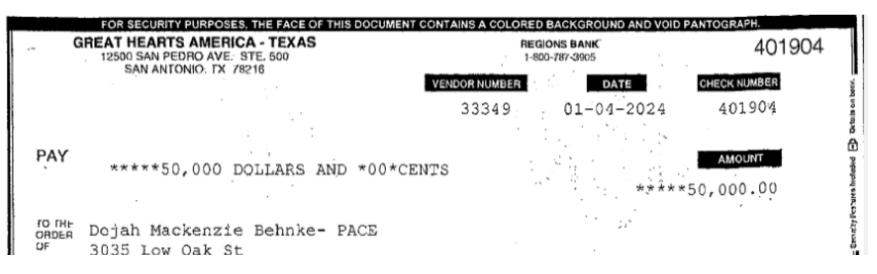
